Telecom Service One Holdings Limited (the "Company") is pleased to announce that at the annual general meeting of the Company held at 19/F., YHC Tower, No. 1 Sheung Yuet Road, Kowloon Bay, Hong Kong at 12:00 noon on 11 August 2014 (the "AGM"), all the proposed resolutions (the "Resolutions") as set out in the circular (the "Circular") incorporating a notice of the AGM dated 27 June 2014 (the "Notice") were duly passed as ordinary resolutions by the shareholders of the Company (the "Shareholders") by way of poll. Unless otherwise defined, terms used herein shall have the same meanings as defined in the Circular.
